




Component 2: Curriculum Development and Support

- A coherent, standards-aligned curriculum, instruction, and assessment system is in place that is culturally and linguistically responsive and meets the needs of all learners
- Evidence-based programs, including supplemental and enrichment curricular and instructional materials, are provided and reflect the diverse needs of the student population and provide equitable access for all learners.
- High-quality, stimulating, and rigorous instructional materials that engage English learners (ELs), students with disabilities (SWDs), foster and homeless youth, and accelerate grade-level content and language development.
- A clearly articulated and executed plan that ensures ELs across all levels of language proficiency can access, fully engage with, and achieve rigorous grade-level academic content standards

Textbook Adoption

- ❖ Create a designated assignment, in addition to Lottery Funds, to ensure that materials can be purchased and paid for over 3-4 years
- ❖ Create an adoption calendar to ensure students have high quality instructional materials (print/ digital)




Budget Implications

Current Funding Sources for Base Program Materials

- ❖ Restricted Lottery
- ❖ Base Local Control Funding Formula (LCFF)

Assumptions

- ❖ X Small (AP Computer Science) \$75,000
- ❖ Small Adoption (German I-III) \$700,000
- ❖ Large Adoption (Elem Math) \$3,900,000
- ❖ \$175/student (+10% shipping or handling) as of 21/22, increasing by 5% each year
- ❖ Keeps enrollment steady

- This does not include “one off” textbook needs, such as specific updated Advanced Placement courses (AP), International Baccalaureate (IB), electives and larger scale Special Education curricular changes.



Proposed Next Steps

- Create designated assignment in MYP for materials adoption
- \$175/student (+10% shipping or handling) as of 21/22, increasing by 5% each year
- Finalize adoption calendar schedule aligned to CDE timeline
