

**Contra Costa County Adult Education Consortium (CCCAEC)**  
**AB 104 Adult Education Block Grant (AEBG) Consortium Member Allocations**  
**Memorandum of Understanding with Contra Costa County Office of Education and**  
**Mt. Diablo USD, Adult Education**  
**for Distribution of 2018/2019 Funds and Required Information for State Reporting**

This Memorandum of Understanding is entered into between Contra Costa County Office of Education, hereinafter referred to as "Fiscal Agent", and Mt Diablo USD, Adult Education, hereinafter referred to as "Member District". This agreement will commence on July 1, 2018 and conclude on June 30, 2020. The purpose of this agreement is to establish the responsibilities of both parties in serving the Contra Costa County Adult Education Consortium, hereinafter referred to as "Consortium."

Basis & Terms: Member District will receive their approved 2018-19 allocation in the sum of no more than **\$3,559,655.00**, to be paid by the Fiscal Agent in **twelve monthly installments of \$296,638** following the monthly distribution of the funds to the fiscal agent by the state. The Member District may continue to expend the FY 18-19 funds on program activities through June 30, 2020 and/or in accordance with AEBG guidelines.

Indirect Costs Limit: Indirect costs will be limited to the lesser of the member's prior year indirect cost rate as approved by the State Department of Education, for local educational agency members, or no more than five percent of the total funding received from the adult education block grant.

Fiscal Agent Responsibilities: The Fiscal Agent will establish procedures and work with the Member District to set up a system for fiscal reporting and distribute funds according to the terms in this agreement. The fiscal agent will receive \$144,500 from the Regional Consortium Common Costs for the administration of this fund.

Member District Responsibilities: Funds allocated pursuant to this agreement shall be used by the Member District exclusively for costs associated with the Contra Costa County Adult Education Consortium regional and annual plan, as prescribed by AB104 AEBG budget language, AEBG allowable uses document: [Allowable Uses of AB104 \(AEBG\) Funds](#) "Program Guidance Instructions, Terms & Conditions" [Program Guidance, Instructions, Terms & Conditions](#) for Performance Year 2018-19, and AB104 (AEBG) legislation. Member District will also comply with the monitoring and reporting requirements described in the section below. Monitoring & Reporting Requirements:

Member District shall be responsible for monitoring their own activities and reporting expenditures for all allocated funds directly to the State by object code in order to fulfill the responsibilities of State reporting. This includes any necessary student participation data, expenditure documentation, and any AB104 information necessary for the successful completion of AB104 mandated reports, performance measures, and program outcomes.

Member District will designate a person/persons with proper authority to certify all information submitted to the State. Member District acknowledges and accepts all responsibility for program related expenditures and certifies that expenditures are in compliance with the approved objectives, rules and regulations that govern the AEBG program. Furthermore, Member District accepts all liability for any disallowed costs, should they arise.

A template will be provided to the Member District by the Fiscal Agent, which will include a listing of expenditures by appropriate object code. A narrative of expenditures will also be provided to the Fiscal Agent as well as general ledger reports, which categorize the budget and expenditures by object code for the specific reporting period. These documents shall be submitted on a quarterly basis to the Consortium Manager and Fiscal Agent.

Timeline:

Member District will provide the Fiscal Agent with reports on AB104 expenditures and progress prior to the State reporting due dates in accordance with established Consortium timelines. Additional/other reporting dates may be required by the State and this information will be communicated to Member District. Member District will report expenditures directly to the state as follows (dates subject to change):

- 1 Member District shall indemnify and hold Contra Costa County Office of Education harmless against any liability whatsoever arising from any act or acts of Member District employees.
- 2 Contra Costa County Office of Education shall indemnify and hold Member District harmless against any liability whatsoever arising from any act or acts of Contra Costa County Office of Education employees.
- 3 This Agreement is not intended to, and shall not; create the relationship of agent, servant, employee, partnership, joint venture, or association between Member District and Contra Costa County Office of Education.

This agreement may be revised by mutual written consent of the agencies involved and may be terminated by either agency upon thirty (30) days advance written notice.
