Contractor will provide permaculture design, planning, and site cleanup for the Riverview Middle School (RMS) Garden as part of MDUSD's CDFA Farm to School Incubator Grant Project.

Contractor will include design elements for the RMS Garden that will maximize learning opportunities for students.

Contractor will work collaboratively with the MDUSD team including administrative staff, RMS site staff, CARES After School Program staff, and MDUSD Garden Education Project Directors to plan improvements to the RMS garden.

Contractor will design ADA pathways in the RMS garden, working with team guidance from MDUSD Maintenance & Operations.

Contractor may submit receipts for reimbursements of materials and supplies as approved by the MDUSD Garden Education Project Directors and as needed for the improvement of the RMS garden.

Contractor will grade the RMS garden for water catchment, weed abatement and preparation for ADA pathway installation.

Contractor will install ADA pathways, as well as curb cuts with concrete ramps as points of entry into the garden.

Contractor will design and install outdoor classroom elements.
