## USDA BROWN-BOX HANDLING AND STORAGE RATES

Frozen Foods	\$.60 per case/per month
Refrigerated Foods	\$.60 per case/per month
Dry Goods	\$.60 per case/per month

## DELIVERY FEE

Refer to price contract for product delivery fee.

## ANNIVERSARY DATE

When product is put into storage at Gold Star Foods, the entry date is called the "Anniversary Date". All billing for storage is done every 30 calendar days from the anniversary date and one month in advance. You are billed every 30 calendar days on the balance of the product left in each lot at the time of billing.

## HANDLING

There are no handling charges.

## LOT WITHDRAWALS

Each lot withdrawal from storage will be subject to a charge of \$2.50 in addition to the storage rates indicated above.

## MINIMUM CHARGES

There will be a minimum charge of \$10.00 per lot/per month.

## TRANSFER/FREIGHT CHARGES

When Gold Star Foods is asked to pick-up and/or deliver to any product from one location to another, a freight charge will apply. The charge for moving product is \$2.00 per case (\$75.00 minimum). The maximum charge will be \$1,000 for moving a 40,000 pound truckload. This rate applies for movement of product within a 100 mile radius.
