Grades K-5

Courses of study for grades K through 5 shall include the following:

California High School Exit Examination

BP 6162.52

Instruction

The Governing Board desires to ensure that district students who graduate from high school can demonstrate grade-level competency in reading, writing and mathematics and that district students are given the opportunity learn the subjects covered in the high school exit examination (hereinafter the "exam").

The Superintendent or designee shall ensure that district programs and services, including but not limited to instructional materials, staff development and remediation programs, are aligned with the exam.

The Superintendent or designee shall administer the exam as required by law for high school graduation. (Education Code 60850)

The Superintendent or designee shall ensure that English language learners are evaluated to determine if they possess sufficient English language skills at the time of the exam to be assessed with the test. (5 CCR 1217)

If a student does not possess sufficient English language skills to be assessed on the exam, the Superintendent or designee may deter the exam requirements for a period of up to 24 calendar months of enrollment in the California public school system until the student has completed six months of instruction in reading, writing and comprehension in the English language. (Education Code 60852)

Students who do not pass the exam shall be offered sufficient remediation necessary to learn the content of the exam in those areas where they are deficient.

The Board hereby approves all parent/guardian requests for a waiver of the requirement to successfully pass the exit exam for students with disabilities who have taken the exit exam with modifications and have received the equivalent of a passing score on all required subject matter parts of the exam. This approval is subject to a principal's certification that the student has successfully completed all conditions for such a waiver as specified in California Education Code. (Education Code 60851)

High School Exit Examination

AR 6162.52 **Instruction**

Administration

Each student in grade 10 shall be offered the opportunity to take the high school exit examination (hereinafter the "exam") at the spring administration and may take the exam at each subsequent administration, until each section of the exam has been passed. (Education Code 60851; 5 CCR 1204)

The Superintendent or designee shall administer the exam in the district on the dates designated by the Superintendent of Public Instruction as exam days or make-up days. (Education Code 60851)

School personnel at the test site shall be responsible for the accurate identification of eligible students who are to be administered the exam. This identification shall be made through the use of photo identification, positive recognition by the test administrator, or some equivalent means of identification. (5 CCR 1203)

All students may have additional time to complete the exam, within the limits imposed by test security. (5 CCR 1211, 1215)

The results of the exam shall be provided to each student taking the exam in time for the student to retake at the next administration any section of the exam not passed. Students shall take again only those parts of the exam not previously passed. (Education Code 60851)

Any student found to have cheated, assisted others in cheating, or compromised the security of the exam, subsequent to an established due process procedure, shall have his/her test marked "invalid" and not receive a score from that test administration. (5 CCR 1220)

Accommodations for Students with Disabilities

A student with a disability shall be permitted to take the exam with any accommodations or modifications provided for in his/her IEP where determined to be necessary and appropriate. Adopted pursuant to the Individuals with Disabilities Education Act adopted pursuant to the Rehabilitation Act of 1973.

Accommodations provided on the high school exit exam shall be consistent with provision of Board policy 6162.55.

At the parent/guardian's request, the principal shall submit to the superintendent, or his/her designee, a request for a waiver of the requirement to successfully pass the exit exam for a student with a disability who has taken the exit exam with modifications that alter what the test measures and has received the equivalent of a passing score on all required subject matter parts of the exam. The waivers required for such a student will be approved if the principal certifies that the student has all of the following: (Education Code 60851)

- 1. An IEP in place, on the date of testing, that requires the accommodations or modifications to be provided to the student when taking the exit exam.
- 2. Sufficient high school level coursework either satisfactorily completed or in progress in the district's high school level curriculum sufficient to have attained the skills and knowledge otherwise needed to pass the exit exam as signified by at least tenth grade status.
- 3. An individual score report for the student showing that the student has received the equivalent of a passing score on all parts of the exam while using a modification that fundamentally alters what the exit exam measures as determined by the State Board of Education.

Upon receiving the certification from the principal, the superintendent or his/her designee shall determine that the waiver request complies with the state requirements. Written approval or denial of all requests shall be provided to the parents and the Board within five days of its receipt from a principal.

Accommodations for English Language Learners

English language learners may be allowed accommodations on the exam that are necessary and appropriate to afford access to the test consistent with federal law, as long as the accommodations do not fundamentally alter what the exam is designed to measure, including additional time as provided for all students in 5 CCR 1215. (5 CCR 1216, 1217.5)

District and Test Site Coordinators

On or before July 1 of each school year, the Superintendent shall designate an exam coordinator from among district employees and shall notify the publisher of the identity and contact information of the coordinator. The district coordinator, or Superintendent or designee, shall be available throughout the year and shall serve as the liaison between the district and the California

Department of Education for all matters related to the exam. (5 CCR 1209)

Annually, the principal shall designate a test site coordinator for each test site, including but not limited to each charter school, court school and school or program operated by the district, from among district employees. (5 CCR 1210)

Test site coordinators shall ensure that strict supervision is maintained over each student taking the exam, both while the student is in the room in which the test is being administered and during any period the student is granted a break from testing. Access to exam materials is limited to students taking the exam for the purpose of graduating and employees of the district directly responsible for test administration. (5 CCR 1211)

Records

The Superintendent or designee shall maintain a record of all students who participate in each test cycle of the exam. This record shall include the following information for the English/language arts section and the mathematics section for each test cycle: (5 CCR 1205)

- 1. The date on which each section of the exam was offered.
- 2. The names of each student who took each section of the exam.
- 3. The grade level of each student who took each section of the exam.
- 4. Whether each student passed or did not pass the section or sections of the exam taken.

The Superintendent or designee shall maintain the following information in each student's permanent record and shall ensure that the information is entered prior to the subsequent test cycle: (5 CCR 1206)

- 1. The date on which the student took each section of the exam.
- 2. Whether the student passed or did not pass each section of the exam.

Notifications

During the first semester of each school year, the Governing Board shall provide written notification to all students in grades 9 through 12 and to their parents/guardians that, starting in the 2005-06 school year and each year thereafter, each student completing the 12th grade shall be required to successfully pass the exam as a condition of graduation. Such notification shall also be provided to a student who transfers into the district after the beginning of the school year at the time of the student's transfer. The notification shall include, at a minimum, the date(s) of the

exam, the requirements for passing the exam, and the consequences of not passing the exam. The Superintendent or designee shall maintain documentation that written notification was provided to the parent/guardian of each student. (Education Code 48980, 60850; 5 CCR 1208)

Board Policy

Concurrent Enrollment In College Classes

BP 6172.1 **Instruction**

The Superintendent and/or designee desires to provide opportunities for eligible district students to enroll concurrently in courses offered at postsecondary institutions in order to foster individual student achievement, increase opportunities for students to complete college preparatory course requirements or career technical education preparation, and prepare students for a smooth transition into college by providing exposure to the collegiate environment.

The Superintendent and/or designee may recommend a student for community college if the student demonstrates adequate preparation in the discipline to be studied and exhausts all opportunities to enroll in equivalent courses, if any, at his/her school of attendance. (Education Code 48800) The student may receive credit toward high school graduation requirements in addition to credit received from the college.

Approval of Concurrent Enrollment

The Superintendent and/or designee may approve a limited number of students of any age or grade level to apply for part-time or full-time concurrent enrollment in a community college or four-year college when it is determined to be in the student's best interest and the student is adequately prepared for such coursework.

Upon recommendation of the Superintendent and/or designee and with parent/guardian consent, the Superintendent may authorize a student to apply for attendance at a community college during any session or term as a special part-time or full-time student and to undertake one or more courses of instruction offered at the community college level. (Education Code 48800)

Within the enrollment limits and exceptions allowed by law, the Superintendent and/or designee may recommend a student for community college summer session if that student demonstrates adequate preparation in the discipline to be studied and exhausts all opportunities to enroll in an equivalent course, if any, at his/her school of attendance. (Education Code 48800)

Any student's parent/guardian may petition the Superintendent and/or designee to authorize full-time attendance at a community college if he/she believes the student would benefit from advanced scholastic or career technical work that would be available. (Education Code 48800.5)

If the Superintendent and/or designee denies a request for special part-time or full-time enrollment at a community college for a student who is identified as highly gifted and talented as defined in Education Code 52201, the Superintendent and/or designee shall issue its written recommendation and the reasons for the denial within 60 days. The written recommendation and denial shall be issued at the next regularly scheduled Board meeting that falls at least 30 days after the request has been submitted. (Education Code 48800, 48800.5)

Program Evaluation

The Superintendent and/or designee shall upon request report to the Board the number of district students participating in the concurrent enrollment option, their success in completing in postsecondary courses, and any impact on their achievement in district courses.
