**TERMS AND CONDITIONS**

Please read the following terms and conditions carefully before signing this contract.

**ARRIVAL AND DEPARTURE DATES AND TIMES**

All players and coaches associated with the above named high school must arrive in Phoenix, Arizona before 3:00 P.M. Mountain Standard Time on Thursday, October 17, 2013 and may depart anytime on Sunday, October 20, 2013.

**HOTEL ACCOMMODATIONS**

Coaches and administrators associated with the above named high school agree to secure overnight hotel accommodations for this group at the Official Tournament Headquarters, namely the Arizona Grand Resort at 8000 South Arizona Grand Parkway, Phoenix, AZ 85044. Teams are housed at the Arizona Grand in the interest of tournament logistics and safety. Teams located in the Phoenix Metro Area are not required to secure overnight accommodation.

Tournament rate is \$99 per night\* for suites that sleep up to four (4) persons per room. Rate is available to parents, family members, and fans. Reservations must be made according to the instructions set forth by the Arizona Grand Resort and no later than September 16, 2013.

\*rate does not include taxes, gratuities, or an \$8 per night resort services fee (normally \$30)

**OPENING CEREMONIES**

All coaches and players associated with the above named high school are expected to attend the tournament Opening Ceremonies, scheduled for 7:00 P.M. on Thursday, October 17, 2013 in the Grand Ballroom of the Arizona Grand Resort. Dinner will be served and all athletes will be honored. Complimentary tickets for all participating athletes and coaches will be provided; additional tickets may be purchased.
