11. Why are you interested in becoming a Delegate? Please describe the skills and experiences you would bring to the Delegate Assembly. *

I have been a Delegate for Region 7 for the last 4 years and would like to continue. I was a member of the 2021 CSBA conference committee held in San Diego where I was given the privilege of introducing the speakers for one of the workshops. I was also invited to be one of three judges to select the delegate for districts with tied delegate election results.

I also have more than 30 years of public service through elected offices as a School Board Member and a City Council Member, and I was the first Latina to be elected as Mayor of my city.

12. Please describe your activities and involvement on your local board, community, and/or CSBA. *

I completed the CSBA Masters in Governance courses 1 & 2, which were held in Oakland. At the local level, I represented our Board on our School District/City Joint Committee and was a member of the committee for our LCAP Master Plan revision, which was adopted in June 2021. I also served as an AUSD Personnel Commissioner.

I am actively involved in the community with the Antioch Woman's Club, Co-President; the GFWC Mt. Diablo District, District Chair; the Brighter Beginnings Community Clinic Board, Board Member; and the Delta Learning Center Board, Board Member.

13. What do you see as the biggest challenge facing governing boards and how can CSBA help address it? *

Finance continues to be one of our biggest challenges, especially as we continue to resolve the COVID-19 issues that continue to affect our students, staff, and families. The one-time funding has been helpful in addressing some needs, but there are restrictions and deadlines on its use.

School districts need help addressing the challenges to funding that is based on average daily attendance (ADA) as absences related to COVID-19 continue to cause a huge decrease in ADA at the same time that districts are experiencing declining enrollment. Additionally, the Governor is projecting a budget shortfall this year that will negatively affect educational funding at a time when it is critical that districts keep their expanded mental health supports and afterschool programs in place.

Support is also needed in addressing the high cost of district-required contributions to CalSTRS and CalPERS. The CalSTRS rate is 19.1%. The CalPERS rate is currently 26.6% and will rise to 28.3% in 2025-26.

Districts also continue to need adequate funding from the Federal government for Special Education. Although funding did recently increase, it is still not sufficient to meet the program requirements for special education students.

We as school Board Members need to be the voice for our students and families as partners with CSBA, share issues from our communities in order to get support from CSBA, and work with elected officials to provide them with a better understanding regarding the education needs in our schools.
