Between

For the period extending from September 1, 2012 to June 30, 2013

ConnectEd: The California Center for College and Career and Mt. Diablo Unified School District agree to work in partnership to support the use of the pre-algebra and algebra curriculum within an afterschool engineering club hosted in the classroom of Marco Castro at Mt. Diablo High School.

SUMMARY OF MAJOR ACTIVITIES

In collaboration with ConnectEd, Mt. Diablo Unified School District has identified one teacher to participate in professional development training and utilize the pre-algebra and algebra curriculum in the afterschool engineering club. Teacher will participate in the following activities:

Professional Development

- Teacher (Mr. Castro) will attend professional development training on the pre-algebra and algebra curriculum via webinar conducted by Kentaro Iwasaki.

Teach Afterschool Engineering Club

- Trained teacher will implement the pre-algebra and algebra curriculum in the afterschool engineering club.

According to this agreement, and based on this Scope of Activities:

ConnectEd will

1. Coordinate to ensure that all curriculum supplies are readily available.
2. Conduct professional development training on the pre-algebra and/or algebra units.
3. Provide teacher with an honorarium of up to \$2,400 for successful participation in professional development and the engineering club.
4. Provide teacher with coaching.
5. Provide teacher with a budget to purchase snacks.

Mt. Diablo Unified School District will

1. Identify one teacher to conduct the afterschool engineering club.
2. Identify one site to hold the afterschool engineering clubs.
3. Recruit students for participation in the engineering club.


