Project: Pre-Checked (PC) – SMART Classroom Design

Scope of Amendment: ADD Science Classroom Design to Pre-checked (PC) drawings.

Scope of Services: The services included in the Base Architectural Agreement between the Mount Diablo Unified School District and PHd Architects, Inc. dated February 23, 2010 hereby incorporated by reference and included in this agreement.

Schedule for Services:

Amendment generally understood to include:

Scope of work to include comprehensive design and <u>ALL</u> work necessary to incorporate the following:

- *1.* One (1) approximately 1400 square foot chemistry laboratory classroom with student work stations and standing seam roofing system.
- Two (2) approximately 2800 square foot chemistry laboratory classrooms with student work stations and standing seam roofing system. Cluster shall include laboratory preparation area between the two classrooms.
- 3. Design shall incorporate structural design and calculations as necessary to incorporate photo-voltaic (PV) system(s). Review and deferred approval submission to meet requirements by DSA to review/approve contractor designed PV system/installation.
- 4. Unless otherwise noted in this amendment, generally anticipated scope of work is contained within Phd Proposal dated March 31, 2010 (Attached). Proposal is inclusive, but not limited to any modification necessitated by field verification and/or programming with District.

Compensation: The Architect will be compensated on a not to exceed basis. For the purposes of this amendment, a not to exceed value of \$54,200.00 established.
