## Revision to Regular Board Meetings for the 2024 Calendar Year

**WHEREAS**, on December 13, 2023, pursuant to Education Code § 35140, the Governing Board of the Mt. Diablo Unified School District approved Resolution 23/24-28 establishing the Board meetings for 2024;

**WHEREAS**, it has been determined that the December organizational meeting date does not align with California Education Code § 35143 which provides: "In a year in which a regular election for governing board members is conducted, the meeting shall be held on a day within a 15-day period that commences with the second Friday in December following the regular election."; and

**WHEREAS**, the second Friday in December of 2024, next succeeding the election will be on December 13, 2024.

**NOW THEREFORE, BE IT RESOLVED** by the Mt. Diablo Unified School District Board of Education:

- 1. That all of the foregoing recitals are true and correct.
- 2. That a change to the regular meetings for the 2024 calendar is necessary.
- 3. That the date of the December 2024 Board meeting is changed from December 18, 2024 to **December 11, 2024**.
