\$986,770.22 from the Mt. Diablo Unified School
District for use in the City's School Resource Officer
program, and authorizing the City Manager to
Execute an Agreement Defining the Provision and
Funding of School Resource Officers

Resolution No. 16-79

WHEREAS, the City Manager has recommended the approval of a School Resource Officer Program Funding Agreement Between the Mt. Diablo Unified School District and the City of Concord, Amending the Municipal Budget for Fiscal Year 2016-2017 and Appending the Municipal Budget for Fiscal Years 2017-2018 and 2018-2019, and

WHEREAS, the funding agreement deems necessary an amendment to the Municipal Budget for Fiscal Year 2016-2017 based upon the City Council's approval for receipt of funds from the Mt. Diablo Unified School District in the amount of \$319,250.13 for the purpose of supporting the Police Department's School Resource Officer Program; and

WHEREAS, the funding agreement deems necessary the acceptance of \$328,827.63 into the Municipal Budget for Fiscal Year 2017-2018 and the acceptance of \$338,692.46 into the Municipal Budget for Fiscal Year 2018-2019 from the Mt. Diablo Unified School District for the purpose of supporting the Police Department's School Resource Officer Program; and

WHEREAS, the City Council has directed staff as to any amendments or acceptances to the municipal budget thereto.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CONCORD DOES
RESOLVE AS FOLLOWS:

Section 1. Approves the recommendations of the City Manager with regard to the amendment to the Municipal Budget for Fiscal Year 2016-2017 accepting funds in the amount of \$319,250.13 and allocating the funds for use in the City's School Resource Officer Program.

Section 2. Approves the recommendations of the City Manager with regard to acceptance of \$328,827.63 into the Municipal Budget for Fiscal Year 2017-2018 and the acceptance of \$338,692.46

1 into the Municipal Budget for Fiscal Year 2018-2019 from the Mt. Diablo Unified School District,
2 and allocating the funds for use in the City's School Resource Officer Program.

3 **Section 3.** The City Council does hereby authorize the City Manager to execute an agreement
4 defining the provision and funding of school resource officers, in substantially the form at Attachment
5 2 to the staff report and acceptable to the City Attorney.

6 **Section 4.** This resolution shall become effective immediately upon its passage and adoption.
