- Provide and install ACR grade or type L refrigeration piping up to 50' max. Supply insulation, fittings, hangers, supports and hook-up, per industry standarts.

- Provide and install suction line P-traps at evaporator coils and every 12' on vertical risers and least 1/2" downward slope per 10' on horizantal lines for proper oil return.

- Insulate suction line with arma-flex type insulation, 3/4" minumum wall for low temperature and 1/2" minimum wall medium tempretaure.

- Purge & pressure system(s) with nitrogen.

- Vacuum system(s) to 500 microns.

- Charge system(s) with refrigerant as specified in engineering summary.

- Check, test, start-up and final adjustments.
