

MT. DIABLO UNIFIED SCHOOL DISTRICT GOVERNING BOARD RESOLUTION 24/25-38

In Recognition of January as National Slavery and Human Trafficking Prevention Month

WHEREAS, in 2010, President Barack Obama issued a Presidential Proclamation designating each January to be National Slavery and Human Trafficking Prevention Month; and

WHEREAS, slavery was officially abolished in December 1865 by passage of the Thirteenth Amendment, and only recently became illegal worldwide when the last country banned it in 2007; and

WHEREAS, slavery has not ceased to exist but instead has been rebranded and is growing at an alarming rate with victims forced into modern slavery and subjected to commercial sexual exploitation, forced labor, involuntary domestic servitude, forced marriage, and debt bondage; and

WHEREAS, approximately 50 million people worldwide, 23% of whom are children under the age of 18 are victims of trafficking,

WHEREAS, the populations in the United States most vulnerable to human trafficking include children in the foster care and juvenile justice systems, youth who have run away or are homeless, LGBTQ youth, and children without lawful immigration status; and

WHEREAS, the <u>Contra Costa County's Alliance to End Abuse</u> acknowledges that fighting exploitation and human trafficking is a shared community responsibility and therefore has worked with numerous public and private agencies to establish the Contra Costa Human Trafficking Coalition, in order to strengthen the County's comprehensive response to human trafficking initiated by county departments, law enforcement agencies, and numerous community and faith-based organizations; and continuing to build its collaboration by linking with local, regional and federal agencies; and

WHEREAS, Mt. Diablo Unified School District has adopted the PROTECT curriculum to raise awareness of this serious issue in Contra Cost County so students, parents, staff and the broader community will be able to identify the signs of human trafficking, respond sensitively to students who have been trafficked, understand reporting obligations, and create systems and strengthen partnerships between schools and law enforcement to address human trafficking; the majority of MDUSD students in grades 7-12 completed two PROTECT lessons in the fall of 2024 and numerous staff trainings have been conducted; and

NOW, THEREFORE BE IT RESOLVED that the Mt Diablo Unified School District does hereby proclaim January 2025 as NATIONAL SLAVERY AND HUMAN TRAFFICKING PREVENTION MONTH, and urge all residents to participate in the efforts to raise awareness of, and end, all forms of human trafficking in our communities, and encourages schools and law enforcement to continue partnerships that support Contra Costa County's youth impacted by human trafficking.
