AMENDMENT EXTENSION SPECIFICATIONS

In consideration for providing continuing services and additional classroom training, Contra Costa County on behalf of its Employment and Human Services Department's (County), Workforce Development Board, and Mt. Diablo Adult School (Agency) hereby agree to increase the payment limit by \$82,458 from \$199,218 to a new contract payment limit not to exceed \$281,676, and extend the term from February 14, 2011 to June 30, 2011. All other agreement terms remain unchanged, in full force, and in effect except as specifically set forth below.

Contract # 18-235-1 is amended as follows:

- I. Interagency Agreement Standard Form, paragraph 4, is deleted in its entirety and replaced with the following paragraph:
 - 4. **Payment Limit.** County's total payments to Agency under this Agreement shall not exceed \$281,676.00.
- II. Service Plan, **I.** Agency Obligations, is amended to add the following subparagraphs:
 - M. Provide **Introduction to Microsoft Office Training** to 40 Title V participants.
 - N. Provide **Building Performance Institute (BPI)** training for the Building Analyst and Building Envelope certification to 36 participants from the construction industry.

Provide three cohorts of training for up to 12 construction industry participants per class in one week modules @ 40 hours/week on the following dates:

Cohort 1	November 15-19, 2010	Pittsburg Adult Education Center
Cohort 2	December 7-11, 2010	Pittsburg Adult Education Center
Cohort 3	January 3-7, 2011	Pittsburg Adult Education Center

Pending additional demand for training and available resources from the WDB, subsequent cohorts of BPI training may be offered at Mount Diablo Adult Education as well as other adult education campuses in Contra Costa County.
