**8. SERVICE OF SUIT**


Except with respect to any policy issued in any state in which the Company is licensed as an admitted insurer to transact business, it is agreed that in the event suit is instituted against the Company relative to this contract, the Company will submit to the jurisdiction of a court of competent jurisdiction within the United States. Nothing in this clause constitutes or should be understood to constitute a waiver of the Company's rights to commence an action in any court of competent jurisdiction in the United States, to remove an action to a United States District Court, or to seek a transfer of a case to another court as permitted by the laws of the United States or of any state in the United States. It is further agreed that service of process in such suit may be made upon the Company through the Superintendent, Commissioner or Director of Insurance designated by the appropriate state, a registered agent designated by and for the Company for the relevant state or other person specified for that purpose in an applicable state statute. The Company hereby designates the General Counsel of the Company, located at 400 Atlantic Street, 8<sup>th</sup> Floor, Stamford, CT 06901, as the person to whom the Superintendent, Commissioner or Director of Insurance designated by the appropriate state, a registered agent designated by and for the Company for the relevant state or other person specified for that purpose in an applicable state statute is authorized to mail such process or a true copy thereof, in compliance with the applicable statutes governing service of process.

By Acceptance of this policy the Insured agrees that the statements in the Declarations and the Application and any attachments hereto are the Insured's agreements and representations and that this policy embodies all agreements existing between the Insured and the Company or any of its representatives relating to this insurance.
