Definition

Plans, organizes, coordinates and directs certificated and classified personnel functions including recruitment and selection of certificated and classified personnel. Leads negotiations with units as assigned, administers the majority of ADA accommodation meetings, monitors and edits HR website and HR social media, coordinates hiring fairs, assists with workers' compensation, and supervises the Benefits Department. Administers collective bargaining agreements, and assists with the duties of Risk Management for the District.
